That in consideration of the mutual obligations herein and hereby assumed, the parties to this contract
severally agree as follows:
1. The club agrees to pay the player for the season of 1925-6, beginning on or about the day of December, 1925, and ending on or about the 20th day of March, 1926

All payments to be made as follows:

In semi-monthly instalments after the commencement of the period covered by this contract, unless this contract shall terminated by the club while the player is "abroad" with the club for the purpose of playing games, in which event the stalment then falling due shall be paid on the first week-day after the return "home" of the club. Provided, however, at if the player is not in the service of the club for the entire season, then he shall receive such proportion of the season's lary, (or of the monthly salary multiplied by four), stated in this contract, as the number of days of actual employment are to the number of days in the season or the number of days in the season plus the additional number of days for which e player is held, provided he be not held more than four months from the beginning of the season.



2. The club may from time to time during the continuance of this contract establish reasonable rules for the government of its players "at home" and "abroad," and such rules shall be a part of this contract as fully as if herein written and binding upon the player; and for violation of such rules or for any conduct impairing the faithful and thorough discharge of the duties incumbent upon the player, the club may impose reasonable fines upon the player and deduct the amount thereof from any money due or to become due to the player. 11. The club shall not transfer the services of the player to any other club without furnishing the player in writing all of the conditions under which said transfer is made and showing what team has claim to his services and what that claim is.
